Sub: ACES - LAN project implementation - Status of all the sites under this Commissionerate - review report.

Please refer to Member's D.O F.No.IV(24)/9/2008 - systems/943 and other references cited above on the above subject . The report called for is submitted hereunder.

2. As directed, a task force has been constituted in this Commissionerate and the details of the e-mail id's have also been communicated to the office of DG(System) under this office letter CNo. 1/1/A2/2008/Comp. dated 28-11-2008. Secondly, the e-mail addresses of assessees are being updated on "Sacer" or "Saps" as soon as the details are collected from the assessees by the Range offices which had been extended broadband facility.

The database updation job previously performed by the data entry officers are now being done at the Range level. Hence the e-mail details are collected from the assessees regularly and are updated in the case of all assessees except those marked

as defunct. Currently there are no issues in the case of updation of location codes (Com./Div./Range) as far as excise and service tax registrations are concerned. Field offices have also been instructed as to how to delete the de-registered / non-existing units and this job will be monitored regularly.

- 3. Regarding the instructions contained in DG's letter dated 10-11-08 on the issue acknowledging the receipt of LAN materials at the respective (Divisions/Ranges), it is submitted that all field formations of this Commissionerate have accepted the packages delivered so far and they have been instructed to verify only the package quantity and not the contents in the package. They have also been warned against refusal to receive the packages from the vendor supplying the goods. However, there are a few exceptions to this arrangement: DGSM and the vendor have been requested to stop the delivery of LAN materials to two formations, viz. the Hqrs.Office of the Commissioner and Tiruvannamalai Range Office, on account of office space re-alignment work and shifting of office premises respectively. Besides the referred letter dated 10-11-08, the points covered under the letter dated 4-12-08 on unresolved issues in respect of DG Set / LAN installation work, have also been discussed in the meeting convened on 10-12-08 with the representatives of the vendors M/s. HP India Sales Ltd., and M/s. CMC Ltd, Chennai, the officials of the C.P.W.D. and the local officers from all the sites.
